

Privacy Notice – Trust Workforce

Introduction

Under data protection law, individuals have a right to be informed about how our trust uses any personal data that we hold about them. We comply with this right by providing 'privacy notices' (sometimes called 'fair processing notices') to individuals where we are processing their personal data.

This privacy notice explains how we collect, store and use personal data about **individuals we employ, or who otherwise engage with our trust** in both paid roles such as teachers and support staff and unpaid roles such as volunteers, governors, trustees. This notice does not form part of any contract of employment or other contract to provide services. We may update this notice at any time but if we do so, we will provide you with an updated copy as soon as reasonably practical.

Brigantia Learning Trust is the 'data controller' for the purposes of data protection law. This means that we are responsible for deciding how we hold and use personal information about you. We will comply with the law and principles, which means that your data will be:

- Used lawfully, fairly and in a transparent way
- Collected only for valid purposes that we have clearly explained to you and not used in any
 way that is incompatible with those purposes
- Relevant to the purposes we have told you about and limited only to those purposes
- Accurate and kept up to date
- Kept only as long as necessary for the purposes we have told you about
- Kept securely

Our data protection officer is **EduDataPro** (see 'Contact us' below).

The personal data we hold

Personal data that we may collect, use, store and share (when appropriate) about you includes, but is not restricted to:

- Your name
- Contact details
- Date of birth, marital status and gender
- Next of kin and emergency contact numbers
- Salary, annual leave, pension and benefits information [Paid roles only]
- Bank account details, payroll records, National Insurance number and tax status information [paid roles only]
- Recruitment information, including copies of right to work documentation, references and other information included in a CV or cover letter or as part of the application process
- Qualifications and employment records, including work history, job titles, working hours, training records and professional memberships
- Disclosure and Barring Service check number
- Teacher reference number
- Performance information
- Outcomes of any disciplinary and/or grievance procedures
- Absence data



- Copy of driving licence or other evidence of identity
- Information about business and pecuniary interests [where relevant]
- Photographs and CCTV images captured within trust premises
- Data about your use of the trust's information and communications system, equipment and facilities
- Results from online searches during the recruitment process

We may also collect, use, store and share (when appropriate) information about you that falls into "special categories" of more sensitive personal data. This includes, but is not restricted to, information about:

- Any health conditions you have that we need to be aware of including information about disability and access requirements
- Absence & Sickness records, occupational health referrals and reports or statements of fitness for work from you GP or hospital
- Ethnicity
- Biometric data for cashless catering purposes
- Trade union membership

We may also collect, use, store and share (when appropriate) information about criminal convictions and offences.

We may also hold data about you that we have received from other organisations, including other schools and local authorities, and the Disclosure and Barring Service (DBS) in respect of criminal offence data.

Why we use this data

We collect and use the data listed above to:

- a. Enable you to be paid [paid roles only]
- b. Check your entitlement to work in the UK
- c. Determine the terms on which you work for us
- b. Facilitate safe recruitment, as part of our safeguarding obligations towards pupils
- c. Support effective performance management
- d. Inform our recruitment and retention policies
- e. Allow better financial modelling and planning
- f. Enable equalities monitoring
- g. Improve the management of workforce data across the sector
- h. Ensure that appropriate access arrangements can be provided for people that require them
- i. Establish and maintain effective governance
- j. Meet statutory obligations for publishing and sharing governors/trustee's details
- k. Make sure our information and communication systems, equipment and facilities (e.g. school computers) are used appropriately, legally and safely
- To ensure network and information security, including preventing unauthorised access to our computer and electronic communications systems and preventing malicious software distribution.
- k. Support the work of the School Teachers' Review Body
- I. Ascertain your fitness to work
- m. Manage sickness absence



If you fail to provide certain information when requested, we may not be able to perform the contract we have entered into with you (such as paying you or providing a benefit), or we may be prevented from complying with our legal obligations (such as to ensure the health and safety of our workers).

We will only use your personal information for the purposes for which we have collected it, unless we reasonably consider that we need to use it for another reason and that reason is compatible with the original purpose. If we need to use your personal information for an unrelated purpose, we will notify you and explain the legal basis which allows us to do so.

Please note that we may process your personal information without your knowledge or consent, in compliance with the above rules, where this is required or permitted by law.

Use of your personal data for marketing purposes

Where you have given, us consent to do so, we may send you marketing information by email or text promoting events, campaigns, charitable causes or services that may be of interest to you. You can withdraw consent or 'opt out' of receiving these emails and/or texts at any time by clicking on the 'Unsubscribe' link at the bottom of any such communication, or by contacting us (see 'Contact us' below).

Use of your personal data in automated decision making and profiling

We do not currently process any personal data through automated decision making or profiling. If this changes in the future, we will amend any relevant privacy notices in order to explain the processing to you, including your right to object to it.

Use of your personal data for filtering and monitoring purposes

While you're in our school, we may monitor your use of our information and communication systems, equipment and facilities (e.g. school computers). We do this so that we can:

- Comply with health and safety and other legal obligations
- Comply with our policies (e.g. child protection policy, IT acceptable use policy) and our legal obligations
- Keep our network(s) and devices safe from unauthorised access, and prevent malicious software from harming our network(s)
- Protect your welfare

Our lawful basis for using this data

Our lawful bases for processing your personal data for the purposes listed in section 3 above are as follows:

- Contract (GDPR Art6(1)b): the processing is necessary for a contract you have with the
 individual, or because they have asked you to take specific steps before entering into a
 contract. For example: Employed staff have a contract with the trust
- Legal obligation (GDPR Art6(1)c): the processing is necessary for you to comply with the law (not including contractual obligations). We need to process data to meet our responsibilities under law as set out here: https://www.gov.uk/government/collections/statutory-guidance-schoolsAn example of this is 'safeguarding children and young people'
- Public task (GDPR Art6(1)e): the processing is necessary for you to perform a task in the
 public interest or for your official functions, and the task or function has a clear basis in law.
 Operating and managing an academy or trust is considered a 'task in the public interest'.

• We have requested for your **Consent** to use the data in a certain way

Where you have provided us with consent to use your data, you may withdraw this consent at any time. We will make this clear when requesting your consent, and explain how you would go about withdrawing consent if you wish to do so.

Some of the reasons listed above for collecting and using personal information about you overlap, and there may be several grounds which justify the trust's use of your data.

Our basis for using special category data

For 'special category' data, we only collect and use it when we have both a lawful basis, as set out above, and one of the following conditions for processing as set out in data protection law:

- We have obtained your explicit consent to use your personal data in a certain way
- We need to perform or exercise an obligation or right in relation to **employment**, social security or social protection law
- We need to protect an individual's **vital interests** (i.e. protect your life or someone else's life), in situations where you're physically or legally incapable of giving consent
- The data concerned has already been made manifestly public by you
- We need to process it for the establishment, exercise or defence of legal claims
- We need to process it for reasons of substantial public interest as defined in legislation
- We need to process it for health or social care purposes, and the processing is done by, or
 under the direction of, a health or social work professional or by any other person obliged to
 confidentiality under law
- We need to process it for **public health** reasons, and the processing is done by, or under the direction of, a health professional or by any other person obliged to confidentiality under
- We need to process it for archiving purposes, scientific or historical research purposes, or for statistical purposes, and the processing is in the public interest

For criminal offence data, we will only collect and use it when we have both a lawful basis, as set out above, and a condition for processing as set out in data protection law. Conditions include:

- We have obtained your consent to use it in a specific way
- We need to protect an individual's vital interests (i.e. protect your life or someone else's life), in situations where you're physically or legally incapable of giving consent
- The data concerned has already been made manifestly public by you
- We need to process it for, or in connection with, legal proceedings, to obtain legal advice, or for the establishment, exercise or defence of legal rights
- We need to process it for reasons of substantial public interest as defined in legislation

Collecting this data

We will only collect and use your data when the law allows us to (as detailed above).

While the majority of information we collect about you is mandatory, there is some information that can be provided voluntarily.

Whenever we seek to collect information from you, we make it clear whether you must provide this information (and if so, what the possible consequences are of not complying), or whether you have a choice.

Most of the data we hold about you will come from you, but we may also hold data about you from:

Local authorities



- Health Authorities, GPs or Occupational Health
- Government departments or agencies
- Police forces, courts, tribunals
- Previous employer or Personal Referee
- Your use of the school network and equipment via our appropriate filtering and monitoring systems in line with DfE guidance

Online searches carried out by the [school/trust] or on behalf of the [school/trust] in-line with the DfE KCSIE 2025 guidance Section 225. "...as part of the shortlisting process schools and colleges should consider carrying out an online search as part of their due diligence on the shortlisted candidates."

Biometric data

Biometric information is collected and used only with consent i.e. cashless catering. If you no longer want to use the biometric system the trust will provide an alternative and delete your information from the system.

How we store this data

We keep personal information about you while you work at our trust. We may also keep it beyond your employment at our trust if this is necessary to comply with our legal requirements or to meet our regulatory requirements. Our data retention policy sets out how long we keep information about staff. For a copy of this please contact the trust office.

We have put in place appropriate security measures to prevent your personal information from being accidentally lost, used or accessed in an unauthorised way, altered or disclosed.

We will dispose of your personal data securely when we no longer have a legal requirement to retain it.

Who we share data with

We routinely share information with:

- Our local authority, Sheffield City Council to meet our legal obligations to share certain information with it, such as safeguarding concerns
- Learn Sheffield
- Governance Service
- The Department of Education e.g. workforce census

We do not share information about you with any third party without consent unless the law and our policies allow us to do so. Where it is legally required, or necessary (and it complies with data protection law), we may share personal information about you with:

- Your family or representatives
- Ofsted, our regulator
- Suppliers and service providers:
 - Signing in/Visitor system
 - o Employment checking services e.g. DBS
 - Payroll providers
 - MIS system provider (Arbor, Unit E, Cedar, Capita SIMs, Safeguarding and accident reporting system)
 - Cashless Payment Systems
 - IT Contractors
 - Print Management



- Online Learning
- o Financial Management Systems
- Media and Design Services
- Financial organisations such as Teachers Pension Scheme and South Yorkshire Pension Authority – LGPS
- HMRC
- Benefit Agencies
- Residential/Educational Visit management System (e.g. EVOLVE)
- Text and Email systems (e.g. EduLink/Arbor)
- Our auditors
- Educators and examining bodies to meet our legal obligations to share certain information with them regarding education and or examination materials and results
- Survey and research organisations e.g. School Teachers' Review Body
- NHS teams and health care professionals
- Health and social welfare organisations
- Occupational Health
- Police forces, courts, tribunals
- Professional advisers and consultants
- Charities and voluntary organisations

Transferring data internationally

We may share personal information about you with the following international third parties outside of the UK, where different data protection legislation applies - including but not limited to

- Google G Suite Hosting [Data Processing Amendment and model contract clauses in place]
- Class Dojo

Where we transfer your personal data to a country or territory outside the UK, we will do so in accordance with data protection law.

In cases where we have to set up safeguarding arrangements to complete this transfer, you can get a copy of these arrangements by contacting us.

Your rights

How to access personal information that we hold about you

You have a right to make a 'subject access request' to gain access to personal information that we hold about you.

If you make a subject access request, and if we do hold information about you, we will (subject to any exemptions that may apply):

- Give you a description of it
- Tell you why we are holding it, how we are processing it, and how long we will keep it for
- Explain where we got it from, if not from you
- Tell you who it has been, or will be, shared with
- Let you know whether any automated decision-making is being applied to the data, and any consequences of this
- Give you a copy of the information in an intelligible form

You may also have the right for your personal information to be transmitted electronically to another organisation in certain circumstances.

Your other rights regarding your data

Under data protection law, you have certain rights regarding how your personal data is used and kept safe. For example, you have the right to:

- Object to our use of your personal data where it is likely to cause, or is causing damage or distress
- Prevent your data being used to send direct marketing
- Object to and challenge the use of your personal data for decisions being taken by automated means (by a computer or machine, rather than by a person)
- In certain circumstances, have inaccurate personal data corrected or blocked
- In certain circumstances, have the personal data we hold about you deleted or destroyed, or restrict its processing
- In certain circumstances, be notified of a data breach
- Make a complaint to the Information Commissioner's Office if you feel we have not used your information in the right way
- Claim compensation for damages caused by a breach of the data protection regulations

We may refuse your information rights request for legitimate reasons, which depend on why we're processing it. Some rights may not apply in these circumstances:

- Your right to have all personal data deleted or destroyed doesn't apply when the lawful basis for processing is legal obligation or public task
- Your right to receive a copy of your personal data, or have your personal data transmitted to another controller, does not apply when the lawful basis for processing is legal obligation, vital interests, public task or legitimate interests
- Right to object to use of your private data doesn't apply when the lawful basis for processing is contract, legal obligation or vital interests. And if the lawful basis is consent, you don't haven't the right to object, but you have the right to withdraw consent

Complaints

We take any complaints about our collection and use of personal information very seriously. If you think that our collection or use of personal information is unfair, misleading, or inappropriate, or have any other concern about our data processing, please raise this with us in the first instance. You can make a data protection complaint to us at any time by contacting [Name and contact details of your data protection officer/lead, whoever is most appropriate].

When a data protection complaint is lodged with us, we will:

- Acknowledge the complaint within 30 days
- Take appropriate steps to investigate the complaint
- Inform the complainant of the outcome of the complaint without undue delay
